Introduction

This is the Cookie Policy ("Cookie Policy" or "this policy") for the website Responesta at https://www.responesta.com/ ("Website") and services provided or performed thereunder (collectively, "Service(s)"). It describes the use of cookies and similar technologies on the Website.

Because we are constantly working to improve your experience, this Cookie Policy may be modified by Responesta from time to time. If we do this, we will post the modified Cookie Policy on this page and will indicate the date this Cookie Policy was last updated. Any such changes will become effective immediately upon being posted, or on such date as may be specified by Responesta.

What are cookies?

A cookie is a small text file that a website saves on your computer or mobile device when you visit the site.

There are several categories of cookies and similar technologies based on their purpose:

- **Technically necessary cookies.** These are cookies that are required for the operation of a site. They include, for example, cookies that enable you to log into secure areas, use a shopping cart or make use of e-billing services.
- Analytical/performance cookies. These cookies are used to understand how visitors interact with a website. They can help to improve the way a site works, for example, by ensuring that users are finding what they are looking for easily.
- **Functional cookies.** These cookies are used to recognize you when you return to a site. This enables its owners to personalize the content for you, greet you by name and remember your preferences (for example, your choice of language or region).
- **Targeting/advertisement cookies.** These cookies record your visit to a site, the pages you have visited and the links you have followed. This information is used to make a site and an advertising displayed on it more relevant to your interests.

Cookies	 A cookie is a small file placed onto your device that enables features and functionality of the Website. Any browser visiting our sites may receive cookies from us or cookies from third parties such as our partners or service providers. Cookies do lots of different jobs, like letting you navigate between pages efficiently, remembering your preferences, and generally improving the user experience.
Local storage	Local storage enables a website or application to store information locally on your device(s). Local storage may be used to improve your experience on the Website, for example, by enabling features, remembering your preferences, and speeding up site functionality.
